LETTER OF AGREEMENT BETWEEN NASSAU COUNTY SCHOOLS TRANSPORTATION DEPARTMENT and HILLIARD PARKS AND RECREATION

This agreement is entered into by and between the NASSAU COUNTY DISTRICT SCHOOL BOARD, a body corporate, hereinafter called "NCSB", and HILLIARD PARKS AND RECREATION, hereinafter called "HP&R".

- This is a mutual agreement entered into and for the purpose of providing needed transportation for HP&R for the Nassau County 2019-2020 school year and expires May 22, 2020.
- The NCSB Transportation Department agrees to the following:
 - a) Provide transportation for up to 15 students from the following schools to HP&R located at 37516 Oxford St., Hilliard, FL:
 - i) Hilliard Elementary School
 - b) To bill the HP&R \$270 per month for 10 months, August 2019 through May 2020.
- 3) HP&R agrees to the following:
 - a) Provide NCSB Transportation Department with a current list of students to be transported and notify NCSB Transportation Department of any changes during the course of the year.
 - b) Provide an adult to meet the school bus and escort students from the bus stop.
 - c) Reimburse the NCSB Transportation Department \$270 per month for 10 months, August 2019 through May 2020.
