ITEM-6 Nassau County Emergency Management – Billy Estep

Billy Estep, Nassau County Emergency Management Director explains what emergency management does. Mr. Estep advises the Town Council and the Public although they are under Nassau County, Emergency Management works for all citizens. There are 5 areas of responsibility that emergency management deals with: preparedness, local mitigation strategy, prevention, response and recovery.

If the Town is seeking mitigation dollars the project must be an approved mitigation strategy project. If the Town was to put in box culverts the project would need to be listed as an approved project on the mitigation strategy plan to receive funding from FEMA. Councilman Wollitz ask Mr. Estep why the debris is picked up on the Eastside of the county before the Westside.

Councilman Sim questions why the county is funding the Lake Hampton dam repairs when it is a private dam.

Council President Beasley thanks Mr. Estep for coming and even though there was no category 4 hurricane there was still a lot of wind and flooding damage to the Westside.
