There is no time frame or what will be distributed first.

PUBLIC COMMENTS:

*Glenn Higginbotham of 3754 Wade Dr. speaks as the Land Use Administrator on behalf of the Code Enforcement Officer about section 62-349. He asks the council for advice on effective screening for inoperable vehicles. A tarp in good standing, car cover, fence or vegetation are all acceptable coverage. Mr. Higginbotham states that it has been a pleasure working with the people of the Town. Hilliard has one of the best fire volunteer fire departments he has ever had the privilege of being able so to sever on.

*Betty Edenfield of 37337 Mill St. asks the council how many years' vehicles can be sitting in a yard not being used.

*Billy Joe Franklin of 55520 Bay Rd. has a lot of logging equipment on his property but his is called yard art and there isn't a tarp large enough to cover it.

* Gary Carver of 46174 Middle Rd. is the commander of the AM Vets and if something doesn't get going soon the AM Vets will be homeless. Right now they currently have their

meetings at the American Legion building that is closing. Mr. Carver explains what the AM Vets do and how they help the community.

*Wesley Baker of 45239 Bismark Rd. talks about the American Legion and its members. Mr. Baker explains the need for a new building.

*Eric Lewis of Kings Ferry Rd. speaks against amending the alcoholic beverage code.

*Bobby Franklin of Pratt Siding Rd. speaks for the amendment to the alcoholic beverage code.
